In accordance with Section 15 of the Money Laundering and Terrorism (Prevention) Act, the Supervisor of Insurance requires persons conducting certain transactions at an insurance company to provide proof of identity as well as proof of address. All insurance companies in Belize must ensure that all their customers are in compliance by June 2015 to avoid suspension of our insurance license.

The following are the documents required. Please email or bring in copies of the documents that apply to you to any of our agents or directly to our main office. If you have already met these requirements, please disregard this email.

All documents should be current (not older than 3 months) at the point of sale.
